



Liability Release

Please sign this document online as part of your registration.

This is a legally binding Consent Form and Release of Liability between the family of the above-named student and the Mathematics Foundation of America ("MFOA") concerning participation in the 2021 session of Canada/USA Mathcamp ("Mathcamp"). We ask that both the student and a parent or legal guardian read and sign a copy of this form.

Definition of Virtual Mathcamp

Virtual Mathcamp is a five-week, online summer program featuring online classes, peer-to-peer collaboration, mentorship, and community-building activities. Participants in the program interact and share content with peers and Mathcamp staff through real-time Web conferencing, asynchronous discussions, and individual and collaborative projects.

Participants must comply with Mathcamp's rules 0–4 (as set out in the Rules and Community Guidelines document) and commit to completing the Required Activities.

Use of Technology

Virtual Mathcamp utilizes a variety of online resources, both hosted by Mathcamp and on other platforms, which require students to post, share, and publish work online in both password-protected and open environments. On some of these platforms, Mathcamp will create and administer accounts for student use during the program. In other instances, Mathcamp staff will make use of a Web tool that requires a student to create an account, in which case each student is solely responsible for maintaining or deleting the account.

I agree that the student will use tools and platforms provided by Mathcamp, including any associated online resource or account, only for lawful purposes. I further agree that we should not assume that files or communications created or transmitted using Mathcamp's technological platforms or tools will be private. Mathcamp may review files, record classes, and otherwise monitor student interactions on our systems to maintain smooth program operations and to ensure compliance with policies and applicable laws and regulations.



Assumption of Risk

I affirm that this student's participation in Virtual Mathcamp and its activities is completely voluntary.

I acknowledge that participation in Virtual Mathcamp may involve risks to health and safety due to certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries.

I have accurately reported, as part of camp registration, the above-named student's current medical conditions and restrictions or limitations. The above-named student has permission to engage in all Virtual Mathcamp activities except as noted in the registration. I am responsible for any changes or updates to medical conditions and restrictions added or removed between the dates of submitting this registration and the student's participation at camp. I understand that MFOA is not responsible for illness due to previous injuries, poor health conditions, or illness incidental to participating in Virtual Mathcamp.

I agree to assume full responsibility for any risks, loss, or personal injury that may be sustained by me/my child, and/or any loss or damage to property owned by me/my child, as a result of participating in Virtual Mathcamp.

During or after the summer, Mathcamp may hold optional reunions and/or field trips when it is safe to do so. Such activities, and the travel to and from these events, may involve inherent risk of physical or other injury.

I understand that the best way to make sure that participants remain safe and avoid injury is to follow the rules, regulations, and instructions of the Mathcamp staff. I also understand that, despite safety precautions, MFOA cannot guarantee that I/my child will not be injured. I assume all risks of the student participating in the activities, whether such risks are known or unknown to me at this time.

If the student deviates from any aspect of Mathcamp and engages in a personal activity that is not part of the program, such deviation is purely voluntary and MFOA shall not be liable for any injuries resulting or arising out of such deviation.



Release and Waiver of Claims

I release, hold harmless, and agree not to sue the Mathematics Foundation of America (MFOA), and their officers, employees, volunteers, and any agents from and against all liability, claims, damages, losses, and expenses and demands, including court costs and attorney's fees and expenses, arising out of or related to any loss, damage, and/or injury that may be sustained by me/my child, or to any property belonging to me/my child, while participating in Mathcamp or its follow-up activities.
